2. **Prepare** to implement RAPID in a way that will best support you and your students.

Should I Administer the Optional Comprehension Task?

While RAPID's required screening tasks give you the most reliable data on student risk and skill development, you may want additional, descriptive information about a student's development of listening or reading comprehension skills. If so, you can administer the optional comprehension task.

Sentence Comprehension, a listening task, is recommended for kindergarten students in the fall and winter. It is also recommended for some kindergarten students in the spring, based on their Word Reading score.

Passage Comprehension, a reading task, is recommended for first and second grade students and some kindergarten students in the spring. These tasks are not required because they are not part of the RAPID screening assessment and the calculation of the overall Reading Success Probability Score.

Use the flow charts below to help you determine if you should administer Sentence Comprehension or Passage Comprehension.


